Results

The mega site launch was a resounding success, coinciding with ADNOC Gas PLC's historic IPO. The Abu Dhabi Securities Exchange (ADX) saw the largest IPO of the quarter globally, raising \$2.5 billion. The IPO was oversubscribed 58 times, with shares trading 19% higher than the listing price of AED2.37.

- Demonstrated Omnia's ability to deliver high-impact, complex projects with precision and excellence.
